Please read these Terms and Conditions ("Terms", "Terms and Conditions") carefully before placing an order with Tulmur Holdings ("us", "we"). If you (being the person(s), Company or Business whose name is completed on the Credit Application or the legal entity that owns that name) purchase products from Tulmur Holdings Pty Ltd, you are agreeing to these terms and conditions. Please make sure you agree with these terms and conditions, which you will be directed to read prior to submitting you order.

1. Ordering

- 1.1 New Accounts are required to complete a Credit Application form available from www.tulmur.com.au,
- 1.2 Orders can be placed online, through a Sales Representative, via phone or email,
- 1.3 All orders must reach the minimum order value of \$50 (before GST and freight),
- 1.4 All prices are quoted in Australian Dollars without GST and may change without prior notification,
- 1.5 The total on the order does not include GST and freight,
- 1.6 Items ordered that are temporarily out of stock, will automatically be placed on back order and will be supplied as soon as is available. Backorders can be cancelled until such time that they are picked and packed. Backorders incur freight charges,
- 1.7 Tulmur Holdings reserves the right to cancel new orders if payment arrangements are not established for overdue invoices,
- 1.8 Due to photographic and screen limitations associated with the representation of products, some items may differ to a small extent (for example in colour) from the way they appear on the site,

2. Payment

- 2.1 Payment must be made within thirty (30) colander days of invoice unless prior arrangements have been stipulated in writing to tulmur@iinet.net.au,
- 2.2 We accept payment either via Credit Card (Visa/Mastercard), Cash, Cheque, or Direct Deposit,
- 2.3 All goods remain the property of Tulmur Holdings Pty Ltd until payment is received in full.
- 2.4 If any account falls over 90 days, credit facilities will be revoked until the overdue account is paid or a payment plan established.
- 2.5 Accounts that fall 6 months past due with no payment arrangement in place will be referred to Kearley Lewis collection agency whereby you become liable for associated commission fees. The fee is currently 14% for balances under \$2,000 and 8% for balances over \$2,001)

3. Delivery & Freight

- 3.1 All orders are dispatched via Australia Post.
- 3.2 Freight is calculated and charged on weight and destination of the order.
- 3.2 Tulmur Holdings Pty Ltd cannot be held responsible for delivery times once the items are received by Australia Post and therefore may not be held liable for any losses, liabilities, costs, damages, charges or expenses arising out of late delivery,

4. Faulty Goods and Returns

- 4.1 Credit claim requests must be notified to us within 14 days from receipt of goods. Otherwise, all goods are deemed to be received in good order,
- 4.2 Returns will only be accepted with *prior authorisation*. Only authorised returns of faulty goods will have their freight reimbursed. Any returns made without authorisation are unable to be reimbursed.
- 4.5 Change of mind returns must be authorised by a member of Tulmur Holdings Pty Ltd. Please note that for any change of mind returns, freight is not reimbursable.
